- 2.1 The Airport Committee may arrange for the discharge of their functions by each of the Authorities' Chief Executives or anyone authorised by any Authority to act in the Chief Executive's absence acting in consultation with the Chair or Vice Chair of the Airport Committee.
- 3. Change in District nomination to the Board of Birmingham Airport Holdings Limited (the "Company").
- 3.1 The former West Midlands Joint Committee approved the District nominated Company Directors, for the two-year term expiring 30th June 2020. The appointments included Waheed Nazir, who was nominated by Birmingham City Council.
- 3.2 Birmingham City Council nominated Kevin Hicks, Assistant Director Highways and Infrastructure to serve as a Company Director in place of Waheed Nazir.
- 3.3 In accordance with the Airport Committee constitution, approval has been given to the appointment of Kevin Hicks as a Director of the Company in place of Waheed Nazir for the remainder of the two-year term ending 30th June 2020.

STRATEGIC AVIATION SPECIAL INTEREST GROUP OF THE LOCAL GOVERNMENT ASSOCIATION ("SASIG")

1. Background

- 1.1 SASIG works for Local Authorities in a strategic manner on national aviation policy to reconcile economic, social and environmental issues in a sustainable way.
- 1.2 SASIG's objectives are:
 - to promote the need for long-term, sustainable aviation policies that lead to a reduction in the environmental impact of aviation whilst securing appropriate social and economic benefits:
 - to increase understanding of the local and global impacts of aviation on the environment and communities:
 - to identify and promote the changes needed to move towards sustainable aviation practices within the industry and Government; and
 - to work with other organisations and the Government on the formulation of policy advice.
- 1.3 The Airport Committee has maintained "block" membership of SASIG, entitling the West Midlands to one voting place, together with a further nomination in an observer capacity. Substitutes can be nominated to attend and officers are permitted to act as substitutes. The subscription for 2020/21 is £5,700.
- 1.4 Members are invited to attend three SASIG meetings a year. Meetings are held at 11am, and are currently held virtually, but usually are at Local Government House, Smith Square, SW1P 3HZ. The next scheduled meeting is 16th December 2020, and a further meeting is to be confirmed, but usually takes place in February.

2. Appointments

2.1 Councillor D Vickers (Dudley) and Cllr R Piper (Sandwell) have previously been appointed as voting and observer member respectively, for the period ending July 2020.

3.1 It is recommended that a voting member and observer member are appointed to serve on SASIG for the period ending November 2021.
