While working as a Marie-Sklodowska Curie early stage Research Fellow at the University of Birmingham (UK), Dr. Asamane obtained his PhD exploring nutrition and physical function of ethnic older minorities. Prior to joining the University of Birmingham, Dr. Asamane worked as a district nutrition officer with the Ghana Health service for 5 years in the areas of maternal and child health nutrition.

Dr. Asamane's primary research interests are in public health nutrition and physical activity, dietary assessment techniques, community-based evaluations and interventions, ethnic minority health and ageing. Dr. Asamane has presented his research findings to the general public and academic audiences at several international conferences all over the world and has several peer reviewed publications.

Presently, Dr. Asamane is working as an applied qualitative health researcher at Keele University (UK) on two randomised controlled trials: the Increasing Physical activity In Older People with Chronic Pain (iPOPP) and the PROvision of braces for Patients with knee OsteoArthritis (PROP OA) trials.
