RESPONSE TO PROJECT FIELDS EXAM 78 DOCUMENT

**STATEMENT ON BEHALF OF
BIRMINGHAM CITY COUNCIL**

- 1.1 The screenshots taken by Project Fields and included in Appendix 1 of Exam 78 do not appear to show the full extent of the web pages.
- 1.2 The “History” section was available at the time of consultation, but not in its present form having been re-organised for the ease of users.
- 1.3 The documents which Project Fields claim not to have been available at the time of the consultation period (6th January - 3rd March 2014) is set out in their Appendix 3. Of these documents a number were available for consultation, as shown by the screenshots taken by Project Fields. The documents that were not available during this period are factual updates to existing evidence and further detailed assessment that were made available as soon as practicable. A detailed response to each document in question is provided in the table below.
- 1.4 Planning officers met with Suzanne Webb, representing Project Fields, on 17 April 2014 at her request, to discuss the representations made. There were no further meetings following this.
