

Soho & Handsworth Neighbourhood Planning Forum and Neighbourhood Plan Area boundary application

NOTICE IS GIVEN that Birmingham City Council has received an application under Regulation 8 of the 2012 Neighbourhood Planning Regulations from local community members in Soho and Handsworth for the City Council to designate a Neighbourhood Planning Forum and Neighbourhood Plan area.

The designation of a Neighbourhood Plan Forum and area is the first stage of the process for members of the local community to begin forming a Neighbourhood Development Plan, which is community led. The Council have a legal duty to support the neighbourhood planning process.

The application will now be publicised by the Council for 6 weeks in accordance with Neighbourhood Planning regulations.

Neighbourhood Planning Forum and area boundary

The application includes the proposed geographic Neighbourhood Plan boundary and a statement of how community members have met Neighbourhood Planning regulations to become the relevant body to prepare a Neighbourhood Development Plan.

What are Neighbourhood Development Plans?

A Neighbourhood Plan is a legal planning document, created and led by local communities focused on improving the physical environment of the place where they live and work. Neighbourhood Plans generally focus on land uses and improving local environments (e.g. houses, offices, parks, social, cultural and recreational facilities, green spaces etc). When complete they are used by planning departments to help decide planning applications in the area and can help bring forward regeneration.

The 6 week public consultation begins on Tuesday 20th August and comments must be received by Friday 4th October 2024.

Designation Decision

Any comments received will be considered in the Council's decision to designate the Neighbourhood Plan area boundary and Forum. A decision on the designation of a Neighbourhood Plan area boundary and Forum must be made by the Council within 13 weeks of the start of consultation and will be published on the Council website.
