Statement of Evidence for Path Claim BAP 311

- 1 This path is first recorded on the deposited plans for the proposed Birmingham Corporation Rivers Improvement 1928, the details of Bridge 61 (Section E-F) being labelled "Public Footway leading from Bromford Railway Station to Washwood Heath". (Held by Warwickshire County Record Office at QS111/631.)
- 2 The part around the west and north sides of the factory was diverted to the north (beside the railway) by the Birmingham City Council (Land between Bromford Lane and Common Lane, Washwood Heath) Public Path Diversion Order 1989. The Order was confirmed by the Secretary of State, after inserting a width of 1.5m, on 5 March 1990.
- 3 The section between the River Tame and Bromford Lane was diverted to the north (although the path being diverted was not the route shown on the Ordnance Survey map) by the Birmingham City Council (Bromford Lane, Washwood Heath) Public Path Diversion Order 1989, with a width of 1.5m. The Order was confirmed on 25 January 1990.
- 4 A consultation on a proposed closure of the whole path was carried out in 2003, but no Order was made. The path is, however, blocked at Common Lane and is overgrown.
- 5 The path is recorded on the (undated) City Council map of public rights of way.
- 6 It is considered, therefore, that it is reasonable to allege that the route subsists as a public footpath and should be recorded as such on the definitive Map.
