Statement of Evidence for Path Claim BAP 295

- 1 The route is shown as a road on the map with the Northfield Tithe Apportionment of 1840. (Held by the City Council at the Central Reference Library.
- 2 The route is shown as a road on the first edition of the Ordnance Survey six inch map (1880's).
- 3 The route is labelled as "Cole Holloway" on a Quarter Sessions Highways Order of 1952, which labelled it as to be "retained as public footpath". The Order has a Certificate of Completion dated 6 June 1952. (Held by the City Council in the Central Reference Library, Archives section , at QS/B/21/6 (Box 19, item 6).)
- 4 A short path cutting off the corner at the south end (between Cole Holloway and Woodcock Lane to the east) was closed by the Birmingham City Council (Woodcock Lane, Shenley Fields) Public Path Stopping up Order 1994, which was confirmed on 30 June 1994. This confirms that Cole Holloway is a public highway.
- 5 The route has name boards at each end, a paved surface, and modern street lighting.
- 6 It is considered, therefore, that it is reasonable to allege that the route subsists as a public footpath and should be recorded as such on the Definitive Map.
