

Statement of Evidence for Path Claim BAP 76

- 1 The original path is shown on the first edition of the Ordnance Survey six inch map of 1887.
- 2 The section north of Audley Road was closed by a Quarter Sessions Highways Order of 1935, with a Certificate of 5 July 1935. (The Order is held by the City Council in the Central Reference Library, Archives section at QS/B/21/2(Box 15, item 40).)
- 3 The remaining section is shown on all, recent, large scale, Ordnance Survey maps, including the 'Explorer' sheet and the 1/10,000 scale.
- 4 The path has a tarmac surface, but has been gated at both ends. There is no known Highways Order closing the path.
- 5 It is considered, therefore, that it is reasonable to allege that the route subsists as a public footpath and should be recorded as such on the Definitive Map.
