

STATUTORY DECLARATION

I, MICHAEL ROBERTS, Honorary Secretary to Walmley Golf Club (Wylde Green) Limited ("Golf Club") do solemnly and sincerely declare as follows:

- 1. I make this statutory declaration in accordance with the provisions of the Highways Act 1980 section 31 sub-section (6).
- 2. The Golf Club is and has been since 30 September 1982 the owner of the land known as Walmley Golf Club.
- 3. On 30th September 2001 I, on behalf of the Golf Club, deposited with Birmingham City Council, being the appropriate Council, a statement accompanied by a map delineating the Golf Club's property by red edging which stated that the ways coloured purple on the said map have been dedicated as footpaths and no other ways have been dedicated as highways over the Golf Club's property.
- 4. No additional ways have been dedicated over the land shown edged red on the said map since the statement dated 30th September 2001 and at the present time the Golf Club has no intention of dedicating any more public rights of way over its property.

AND I MAKE this solemn declaration on 7 October 2001 conscientiously believing it to be true and by virtue of the provisions of the Statutory Declarations Act 1835.

5. The deposit shall comprise this statement and the accompanying Map.

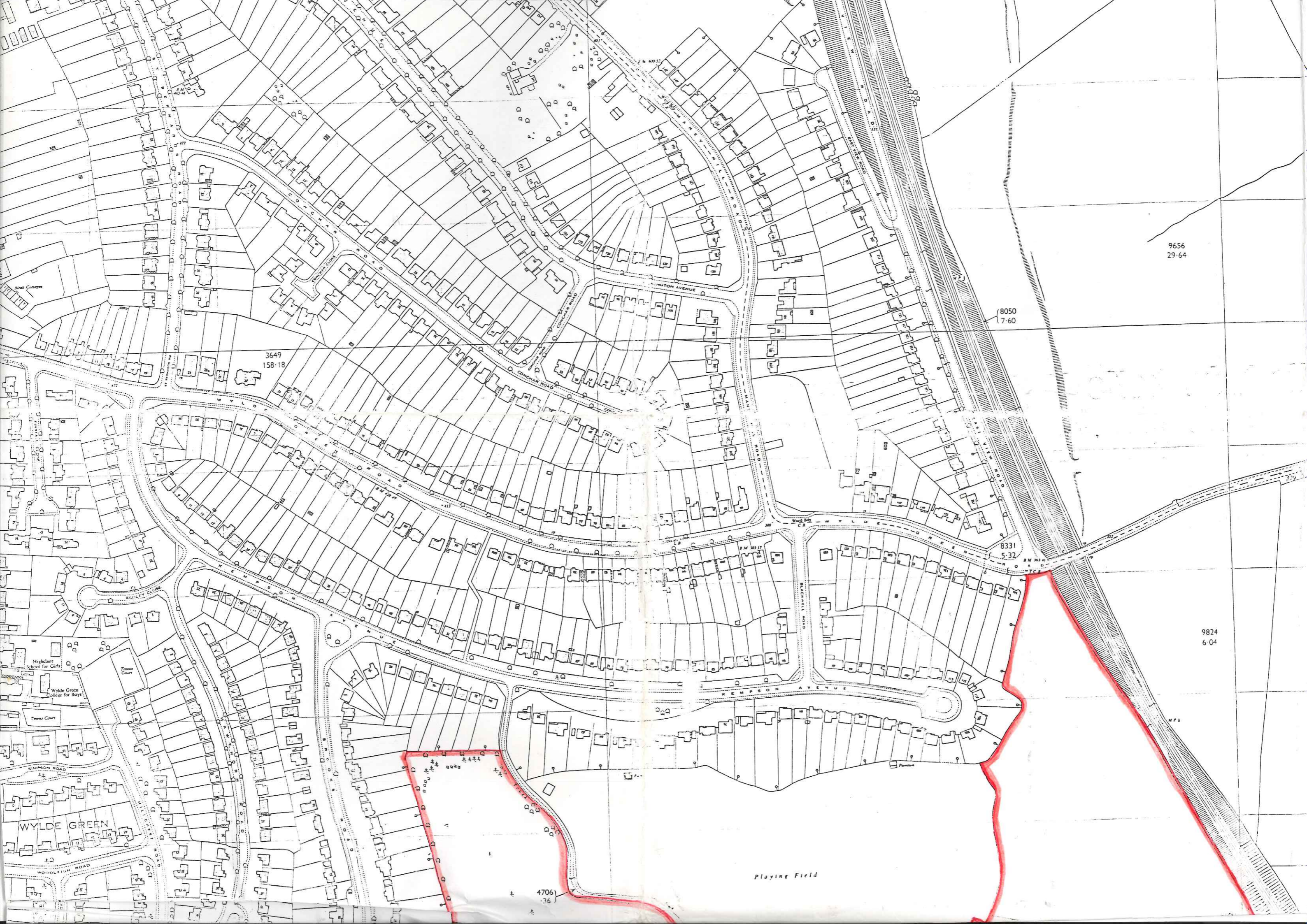

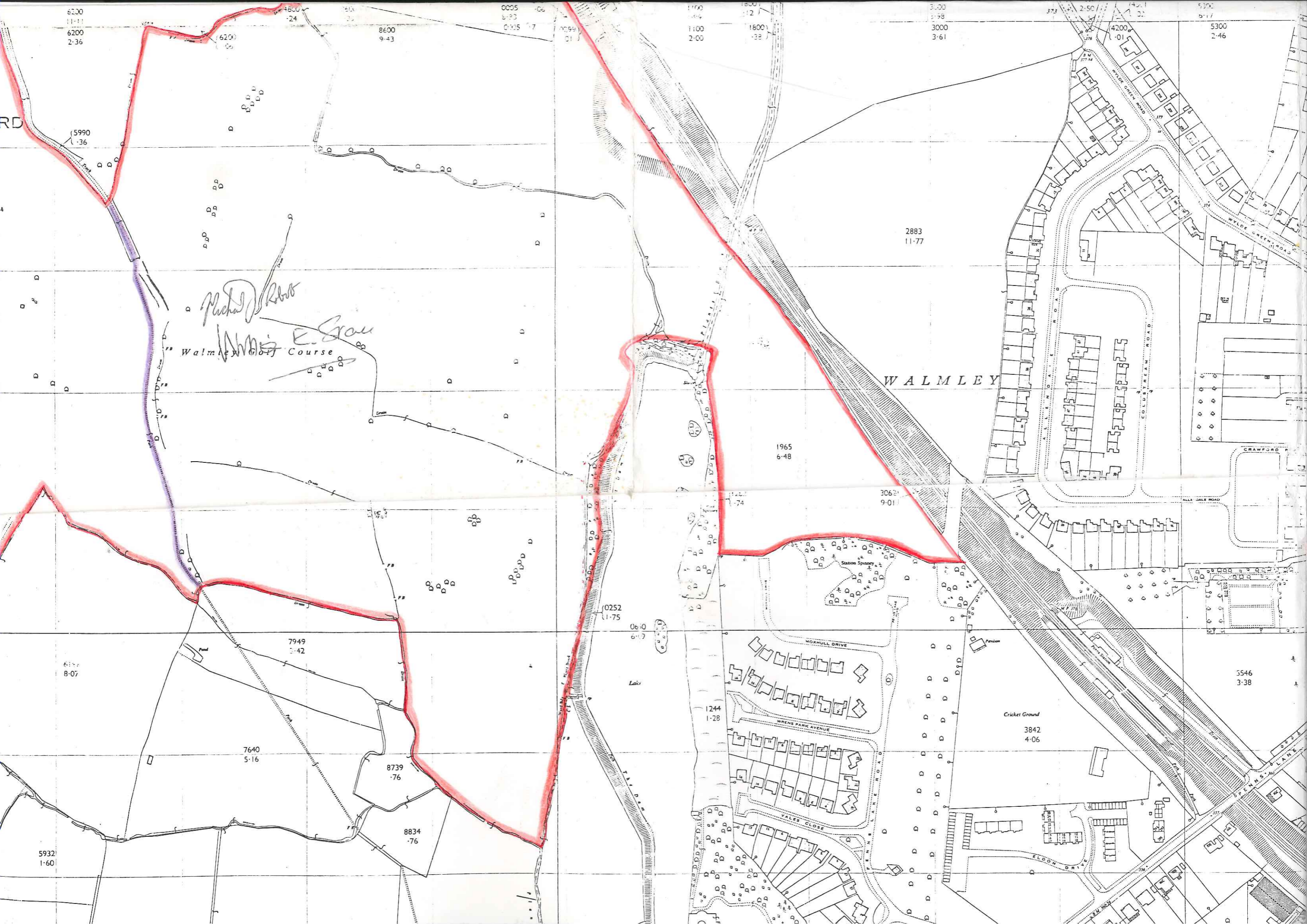

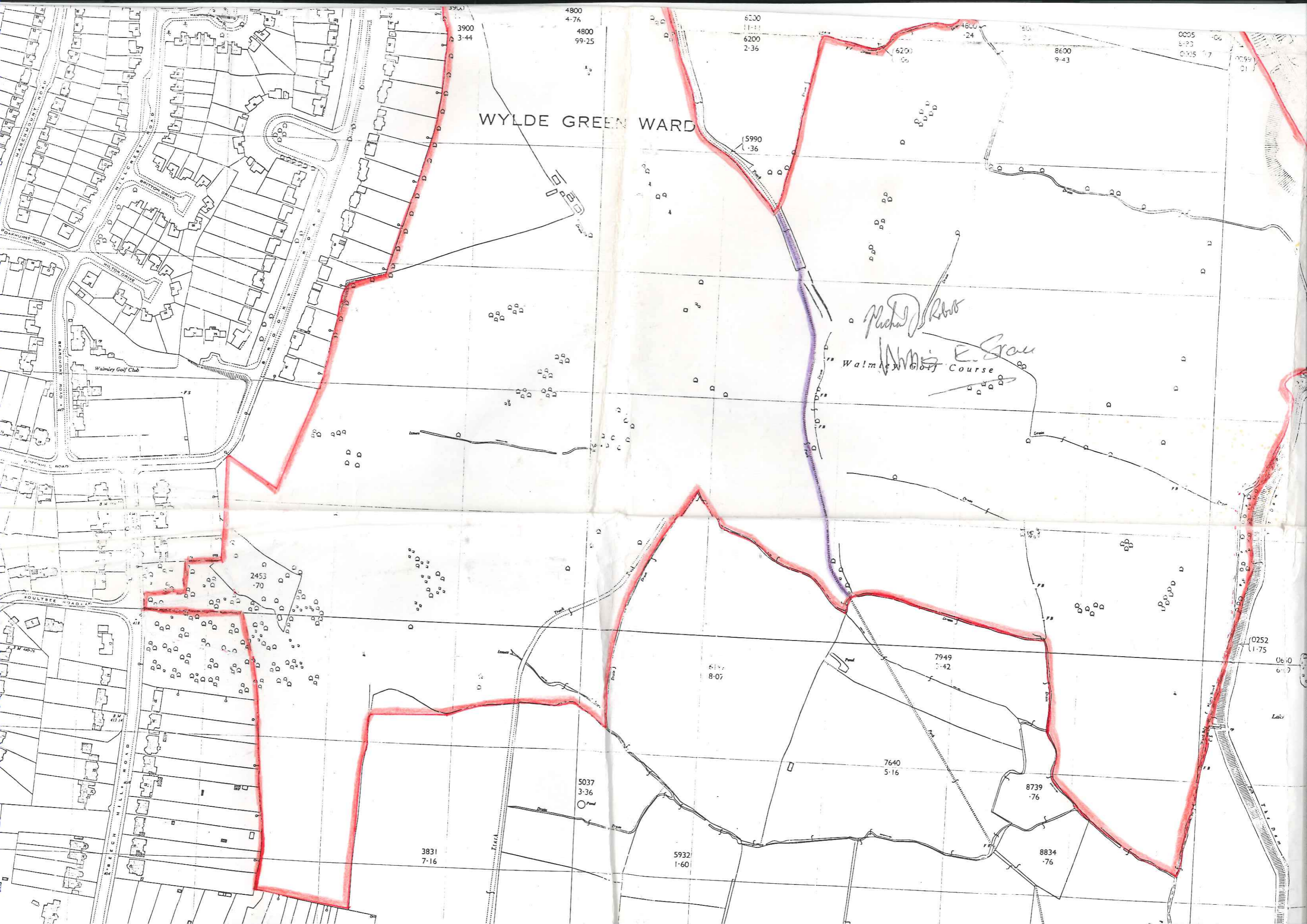
