Statement of Evidence for Path Claim BAP 130

- 1 The path is first recorded on the deposited plans for the London and North Western Railway (Birmingham and Lichfield Line) 1846, in two parcels in Sutton Coldfield parish. The Book of Reference describes these as parcel 231: field and public footpath, and parcel 232: field and public footpath. (Held by the Warwickshire County Record Office at QS111/195.)
- 2 The path is recorded on the deposited plans for the Birmingham and Sutton Coldfield Extension Railway 1862 in two parcels. The Book of Reference lists parcels 91a and 93 as "Foot-path", with no occupier. (Held by WCRO at QS111/237.)
- 3 The path is recorded on the deposited plans for the Birmingham and Sutton Coldfield Railway 1866 in two parcels in Sutton Coldfield parish. The Book of Reference lists parcels 91 and 92 as "arable and footpath". (Held by WCRO at QS111/292.)
- 4 The path is recorded on the deposited plans for the Birmingham and Lichfield Junction Railway 1871, in two parcels. The Book of Reference lists parcels 74 and 75 as "arable field and footpath". (Held by WCRO at QS111/313.)
- 5 The path is recorded on the deposited plans for the London and North Western Railway (Sutton Coldfield and Lichfield Railway) 1879, in two parcels. The Book of Reference lists parcels 177 and 178 as "field and public footpath", with the owners including the Board of Surveyors of the Highways. (Held by WCRO at QS111/360.)
- 6 The path is shown, and labelled 'FP' on both sides of the railway on the first edition (1884) of the Ordnance Survey six inch map.
- 7 The path is recorded on the (undated) City Council map of public rights of way.
- 8 The path is surfaced with tarmac and paving slabs, has an anti-cycle barrier, an iron "Public Footpath" sign at the Lichfield Road, and a post with the arm missing at Clarence Road.
- 9 It is considered, therefore, that it is reasonable to allege that the route subsists as a public footpath and should be recorded as such on the Definitive Map.
